CO₂ at fill prices: under 200z: \$5.00

200z+: \$10.00

Preregistration includes mess kit (i.e. meal ticket), game ID, and entry into door prize draws. Your Registration Form *must* include a properly completed Field Waiver. If you are under 18, you will need a parent or guardian to sign the waiver for you.

Camping space *is available* at the site, but you will need to bring your own water and food. There are ready-johns on site.

*Note: each **player** must complete a registration package. Please make copies of these forms for each player you want to register.*

1. Complete the attached Scenario Game 2010 Registration Form (one copy for each player entering).
2. Complete the attached Waiver and Indemnification Form (one copy for each player entering). If being completed for a player under the age of 18, a parent or legal guardian must sign the waiver.
3. Improper or incomplete waivers will delay the processing of your registration, which will likely put you into the higher-price category and require \$5 extra. Make sure you have all your paperwork in order, soldier!
4. Enclose the appropriate fee for *each* player registering: \$20 per player if postmarked by 30-AUG-2010, \$25 per player afterwards. Enclose *only* cheque or postal money order — do **not** send cash through the mail!

I, the undersigned, wish to engage in the activities offered by this playing field, and any other SPIKE'S PAINTBALL (PEI) approved playing fields, and hereby sign this application to indicate my acceptance of the opportunity to play this sport.

I understand that the activities are physically and mentally intense and may require extreme exertion to play, and that the possibility of injury to myself and others does exist. **I understand** that the activities can be dangerous if not played in accordance with stated rules which have been explained to me and which I understand and will abide by.

I confirm and agree that I am fully aware of the risk and that I am physically and mentally able to be fully involved in these activities and will comply with the rules, regulations and the full and complete use of all equipment so as not to be injured or to hurt myself or other participants.

Release: I hereby release and forever discharge from any claim and liabilities whatsoever without limitations that I might have against SPIKE'S PAINTBALL (PEI) authorized playing field (wherever located and whenever I might play) or related activities, and any operator or their personnel (hereinafter called the Sponsors and Property Owners), procedures and liabilities arising out of connection with, or resulting from playing the game, including without limitations, those resulting from the manufacture, selection, delivery, possession, use or operation of the equipment of the game. I hereby release the Sponsors and Property Owners from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors and Property Owners that I am in good health and do not suffer from a heart condition or other ailments which could be exacerbated in playing the game.

Assumption of Risk: I confirm that I either have specific insurance to cover any injuries that I may sustain or cause to others, and that SPIKE'S PAINTBALL (PEI) or their employees will not be held responsible for any injuries sustained, and that I have read and fully understand the terms of this agreement. I UNDERSTAND THAT THIS IS FULLY INTENDED TO BE A LEGAL CONTRACT FOR A PERIOD OF ONE YEAR FROM THE DATE OF SIGNING; IF I HAVE ANY DOUBTS CONCERNING ANY ASPECT OF ITS CONTENT, I WILL CONSULT AN ATTORNEY BEFORE SIGNING IT.
